This letter is a reminder notice of your court date scheduled on July 15, 2020.

Please bring YOUR OWN PEN (blue or black ink) to sign court documents. Face coverings required.

IMPORTANT INFORMATION-MUST READ

COVID-19 HEALTH AND SAFETY PROCEDURE UPON ENTERING THE BUILDING

Recognizing the need to ensure the health and safety of all litigants, attorneys, visitors, court staff, and judges, the city has implemented the following health and safety protective measures:

1. **When arriving at city hall, there will be a health screening process** before you will be permitted to enter the courtroom.
2. **No one that is not on a court docket will be allowed to enter the building**. That includes all children. If you are a juvenile or minor that is on the docket, one parent or guardian will be permitted to enter with you. Also, all attorneys representing defendants on the docket will be permitted to enter. Everyone will be required to go through the initial health screening process before entering the courtroom.
3. **Protective Measures:** The court encourages all to wear facial coverings or medical masks that cover both the nose and mouth. If you do not have one and would like to wear a mask, the court can supply one to you while supplies last. Hand sanitizer and tissues are available throughout the building and courtroom. To comply with the social distancing 6ft. requirements, only 2 people at a time will be allowed in the restrooms. All community water fountains will not be permitted to be used. ~~The city hall lobby, the courtroom and the restrooms will be sanitized~~ for your protection. The court room will be set up according to the 6ft. social distancing requirements.
4. **Individuals that are currently experiencing symptoms** such as fever, cough, shortness of breath or difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, loss of taste or smell, diarrhea, or having known to have been in close contact with a person who has been confirmed to have COVID-19, or showing symptoms of the virus, **will not be permitted to enter the building and should contact the court immediately** so that your case can be reset for another date. After seeing a medical professional, you must provide the court with a written doctor's release confirming that you do not have the virus or are clear of any contagious virus or sickness before you will be permitted to enter the city hall building to attend any court hearings.
5. **Individuals who are over age 65 and individuals with serious underlying health conditions**, such as high blood pressure, chronic lung disease, diabetes, obesity, asthma, and those whose immune systems are compromised by chemotherapy for cancer or other conditions requiring such therapy are considered to be vulnerable populations. Please contact the court immediately so that we can reset your hearing or trial until such time that you can safely appear in person.

It is your responsibility to notify the court immediately if you have any changes to your mailing address, email address, or telephone number until the final disposition of your case. Please contact the court immediately with any changes you may have.
