## 5. CITIZEN INQUIRIES - NOT TO EXCEED THREE MINUTES

Wayne Matthews – 2419 Michaelangelo – Requested an update on the work to be done on the Michaelangelo ditch work and FEMA contract. Wanted Council to know that a tree fell into his yard and the ditch and that the ditch needs to be managed due to safety issues.

Taylor Olsen – 2559 Fountain View – Suggested using Hubbard Park as a dog park. He is willing to volunteer to get dimensions, quotes on fencing and help if needed.

Larry Sanders – Voiced his opinion that permits in the city are too high and would like Council to look into a more reasonable fee schedule. Look into a different inspection company to use if possible, getting an electronic marquee sign and use of online information for residents. He mentioned his concern with Kings Colony and other surrounding areas and firearm issues. Announced that his daughter Kerri Larson is working with a rescue group to rescue animals in the area.

## 6. Discussion and possible action on the purchase of a Mini Excavator.

Councilmember Koepsel made a motion to purchase the Sunward Mini Excavator from Cool River Equipment in the amount of \$52,850.00 with equipment as listed; Councilmember Mullane seconded the motion. Votes in favor: Unanimous.

7. Discussion and possible action concerning Resolution 438-22 – A RESOLUTION REGARDING A FINANCE CONTRACT FOR THE PURPOSE OF FINANCING A MINI EXCAVATOR.

Councilmember Koepsel made a motion to approve Resolution 438-22 for the finance contract for the mini excavator on the 7-year term at 3.024%; Councilmember Partin seconded the motion. Votes in favor: Unanimous.

8. Discussion and possible action concerning and construction of a fence around the maintenance building and naming a funding source.

Councilmember Koepsel made a motion to approve the purchase and construction of a fence not tying into the neighbor's fence line with materials stated at the price of \$5904.00 from Capital Outlay-Public Works; Councilmember Partin seconded the motion. Votes in favor: Unanimous.

Councilmember Koepsel made a motion to adjourn the Special City Council Meeting; Councilmember Adkins seconded the motion. Votes in favor: Unanimous.
