Councilmember Brooks made a motion to approve all Consent Agenda items as written; Councilmember Adkins seconded the motion. Votes in favor: Unanimous.

7. City Engineer Greg Phipps Report:

City Paving issues:

City Engineer Phipps stated the five pavement failures on Brutus are due to lack of subbase causing base failures which is not the contractor's fault and the City would have to pay for the repairs. The subgrade failures in Section 2 are due to asphalt issues. Options to repair are 1. Reseal; or 2. Strip and Overlay, which does not address the underlying issue and we will continue to see failures. A letter to the contractor will be presented to Hayden Paving to ask if they will honor their prior agreement to do the seal or any additional repair work at their previously bid pricing before the City goes out for other bids or goes to their Maintenance Bonding Company.

Phase 4 – The acquisition of the road bond is still outstanding from the developer.

City Drainage Improvements:

Waiting on a walk through with Council on Venus Ditch.

Updates were given on the Michelangelo and Shrek Outfall projects and the revised plans that are being explored prior to obtaining new estimate.

8. ORDINANCE NO. 205-22 — AN ORDINANCE OF THE CITY OF ROMAN FOREST, TEXAS, REPEALING AND REPLACING CHAPTER 28, ARTICLE II, "WEEDS, BRUSH, RUBBISH, AND OTHER UNSIGHTLY MATTER;" AUTHORIZING THE CITY COUNCIL OF THE CITY OR ROMAN FOREST, TEXAS, PURSUANT TO CHAPTER 342, TEXAS HEALTH AND SAFETY CODE, TO DESIGNATE AND DECLARE UNLAWFUL CERTAIN CONDITIONS PERTAINING TO UNSANITARY AND HEALTH HAZARDS; PROVIDING DEFINITIONS; PRESUMPTION AS TO PERSONAL PROPERTY; PROVIDING FOR DISCOVERY NOTICE TO ABATE AND COST AND EXPENSES, MINIMUM CHARGE, ASSESSMENT AND COLLECTION; ABATEMENT OF DANGEROUS WEEDS; PERFECTING, ENFORCING LIEN AND RELEASE; PROVIDING FOR ADMINISTRATION OF FINANCES; PROVIDING FOR AWARDING OF CONTRACTS BY CITY AND OWNER OR OWNERS FOR REMOVAL OF UNLAWFUL CONDITIONS; PROVIDING \$500 PENALTY FOR FAILURE TO ABATE; PROVIDING FOR SUMMARY ABATEMENT; PROVIDING SAVINGS CLAUSE; REPEALING CITY ORDINANCE NO. 205 DATED JULY 15, 1991 AND ALL CONFLICTING ORDINANCES; PROVIDING A TEXAS OPEN MEETINGS ACT CLAUSE; AND PROVIDING AN EFFECTIVE DATE AFTER PUBLICATION.

Councilmember Mullane made a motion to amend and approve the ORD 205-22 as written; Councilmember Brooks seconded the motion. Votes in favor: Unanimous.

9. ORDINANCE 266-20 - AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF ROMAN FOREST, TEXAS, DECLINING TO APPROVE THE CHANGE IN RATES REQUESTED IN ENTERGY TEXAS, INC.'S ("ETI" OR "COMPANY") STATEMENT OF INTENT FILED WITH THE CITY ON JANUARY 31, 2022, AND FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE WAS CONSIDERED WAS OPEN TO THE PUBLIC AND IN ACCORANCE WITH TEXAS LAW.

Councilmember Adkins made a motion to decline approving the rate increase requested by Entergy Texas, Inc.; Councilmember Mullane seconded the motion. Votes in favor: Unanimous.

10. Councilmember Lori Jo Koepsel – Position 1 resignation letter.

Councilmember Brooks made a motion to accept the resignation of Councilmember Koepsel; Councilmember Mullane seconded the motion. Votes in favor: Unanimous.

11. Filling the Vacancy of Council Position 1.

Tabled - No Action taken.

12. David Thornberry's request for the City to annex additional lots.

Mr. Thornberry is requesting the City to annex additional lots he owns which are not in public utility district. There are contiguous lots mixed in with the lots owned by Mr. Thornberry who would need to be involved in the annexation process. City Attorney Forester advised against taking any action on this request at this time pending further research on annexation laws. No action taken.

13. Adjourn into closed executive session regarding personnel matters as authorized by the Texas Government Code § 551.074.

14. Action taken from closed executive session related to personnel matters:

It was recommended that Chief Carlisle no longer have the title of Deputy Assistant City Administrator as there was not a need for him to assume that position.

Councilmember Mullane made a motion to withdraw the prior motion appointing Chief Carlise as Deputy Assistant City Administrator; Councilmember Brooks seconded the motion. Votes in favor: Unanimous.

Councilmember Mullane would like to add the sign ordinance and costs to the March agenda.

### 16. ADJOURNMENT

Councilmember Brooks made a motion to adjourn the meeting; Councilmember Adkins seconded the motion. Votes in favor: Unanimous.
